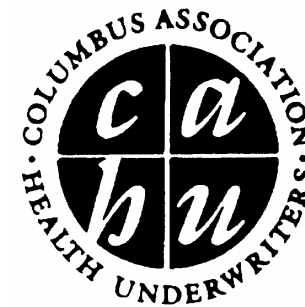

NAHU is your voice in Washington! Each year NAHU spends over \$1,000,000 to present your interests before Congress and regulatory agencies. Legislation

The Ohio Health Insurance Risk Pool will provide coverage for approximately 10,000 Ohioans who cannot get insurance because of medical history or who are faced with premiums so high they can't afford them! No one program can solve all of the problems facing Ohio. But, the Ohio Health Insurance Risk Pool is a great start!
